Judy Zarubick called the meeting to order at 7:00 p.m. and welcomed Council.

3. Lighting of the Candle (Judy Zarubick)

Judy Zarubick offered these words as she lit the candle: "Loving God, we thank you that you are with us, and that we may call upon you no matter where we are, or what we are feeling. Keep us mindful of your presence and trusting in your promise—that you are working with us in the moment-by-moment unfolding of our lives. Amen".

4. **Devotion** (Judy Zarubick)

Judy Zarubick asked Council to do some calm breathing to begin the devotion. Judy Zarubick read from: "The Circle of Life" by Joyce Rupp & Macrina Wiederkehr, page 184, "A Closer Look at Thanksgiving" and led Council in prayer.
